

State of the Order Address Hamilton Edgar Reed State Master Councilor August 1, 1988

Dad Hunt, Distinguished East, my Fellow State Officers, Guest, and most importantly the DeMolays of Florida,

Each and every year the State Master Councilor, at the opening of Conclave gives a State of the Order address. The purpose of this speech is to express his views on the success or failure of his term and any progress or problems that Florida DeMolay has faced in the past 12 months.

At the beginning of the DeMolay year, I was faced with the awesome task of uniting three forces in Florida DeMolay, Those who wanted change now, those who were content with the way things were, and those who were caught in the

middle.

I felt that before this Association could move forward we first had to

stop some fighting and unite for a common purpose.

Throughout this year I have seen opposing sides give and take. For example, at Conclave last year the DeMolays asked for a financial report of the Florida DeMolay Association, Incorporated, and this was printed in the proceedings of the 54th Annual Conclave. I hope that this practice will continue and expand to include all aspects of the Florida DeMolay financial picture.

It is apparent that change is all around Florida DeMolay, more young, enthusiastic advisors have joined the State Staff this year; more than any year in recent memory. Growth cannot occur without change and it is obvious that any organization must grow or die. In recent years change and growth have come too slowly, as a result, Florida DeMolay has suffered. However, change is coming and growth is occurring. I know that there are a few people here who are not happy with the rate of change, and would like to see things turn around much faster. To these people I would like to quote a piece of poetic advice:

"You say you want a revolution, well you know, we all want to change the world, but when you talk about destruction, don't you know that you can count me out. "

We all know that good things take a long time and we must realize that if change is to be effective it must be well planned and properly executed.

The State of the Order of DeMolay in Florida Cannot realize it's fullest potential until the small groups at both ends of the spectrum understand that the only one of the three groups that can really make a difference is the group that includes the average DeMolay, the average advisor, the average mother, and the average sweetheart, the group that is Florida DeMolay.

Minutes of the 55th Annual Session Tuesday August 1, 1988

The regular business session of the 55th Annual Conclave of the Florida DeMolay Association was called to order at 8:00 a.m. by Brother Ed Reed, State Master Councilor.

Brother Reed then turned the chair over to Brother Todd Cottrill, Deputy State Master Councilor. Brother Reed then took the roll call and a delegate count was taken. The delegate count was:

> Total Delegate Count: Simple Majority: 23 Two-Thirds Majority: 33

Brother Reed read the following Credentials Committee Report and its addition in the absence of the Credentials Committee Chairman:

Credentials Committee Report

To the Delegates of the 55th Annual Conclave:

The Credentials Committee has met and the credentials of all delegates

have been validated in accordance with Section 5.05 of the Statutes.

This year at the 55th Annual Conclave for the Jurisdiction of Florida, there are (29) chapters and (2) Past State Master Councilors registered for a total of (86) delegate votes. Assuming that all delegates are present at a session, a majority vote would be (44) and a two-thirds majority vote would be

(58). A quorum to conduct a session is (44).

This Committee would like to remind all advisors that in accordance with section 3.11 of the Statutes, "In the event that less than three (3) delegates from a Chapter are in attendance at Conclave, any or all of the absent delegate votes may be given to a remaining delegate from that Chapter. In order to accomplish this, the Chapter Advisor must submit written authorization to the Credentials Committee before the opening business session of Conclave." Unless this is done, each delegate is allowed only one (1) vote.

This report will have no physical or fiscal impact, pursuant to

Section 5.01.

Brother Reed called upon Brother J. Michael Harper. Chairman of the Constitutional Revisions Committee, to read the following report

Constitutional Revisions Committee Report

To the Delegates of the 55th Annual Conclave: We, the members of the Constitutional Revisions Committee, have met and wish to propose these revisions to the Constitution and Statutes. We hope that they will meet with your approval.

THE FORMAT OF THIS REPORT IS: PRESENT STATUTE; PROPOSAL; NEW STATUTE.

AMENDMENTS TO THE CONSTITUTION

Article IV Officers

Section 1: The Officers of this Association shall consist of the State Master Councilor, Deputy State Master Councilor, State Senior Councilor, State Junior Councilor, State Treasurer, State Scribe, State Master Councilor's Representatives, State Senior Deacon, State Junior Deacon, State Senior Steward, State Junior Steward, State Chaplain, State Marshall, State Orator, State Standard Bearer, State Parliamentarian, Seven State Preceptors, State Committee Chairmen, and all others selected by the State Master Councilor, and/or Executive Officer of the State of Florida.

Article IV, Section 1: Replace "State Treasurer" with "State Parliamentarian" and merge State Treasurer with State Scribe creating a State Scribe/Treasurer.

- Section 1: The Officers of this Association shall consist of the State Master Councilor, Deputy State Master Councilor, State Senior Councilor, State Junior Councilor, State Parliamentarian, State Scribe/ Treasurer, State Master Councilor's Representatives, State Senior Deacon, State Junior Deacon, State Senior Steward, State Junior Steward, State Chaplain, State Marshall, State Orator, State Standard Bearer, Seven State Preceptors, State Committee Chairmen, and all others selected by the State Master Councilor, and/or Executive Officer of the State of Florida.
- Section 2: The State Master Councilor, Deputy State Master Councilor, State Senior Councilor, State Junior Councilor, and State Treasurer shall be elected during the general business session of this Association at Conclave assembled each year, and these officers shall serve until their successors are installed.

- Article IV, Section 2: Change State Treasurer to State Parliamentarian.
- Section 2: The State Master Councilor, Deputy State Master Councilor, State Senior Councilor, State Junior Councilor, and State Parliamentarian shall be elected during the general business session of this Association at Successors are installed.
- Section 3(a): The State Scribe shall be appointed by the Board of Administration from a list of two or more nominees submitted to it by the State Master Councilor. The State Scribe shall be appointed at the Annual Mini-Conclave of this Association, or as provided by Article IV, Section 5(c) he shall not be eligible to run for an elected officer for a period of one year after his appointment. All nominees for the office of State Scribe must be a Past Master Councilor, have completed the Leadership Correspondence Course, and be a Representative DeMolay.
- section 3(b): The State Scribe shall work with an Advisor who is satisfactory to the Board of Administration. The State Scribe shall obtain three (3) or more bids for the cost of printing the Conclave Proceedings before the registration of said Conclave.
- section 3, (a): Add "All candidates for State Scribe/Treasurer must have
 a personal savings and/or checking account."
 Section 3, (a), (b),: insert "/Treasurer" after "State Scribe throughout
 this section.
- Section 3(a): The State Scribe/Treasurer shall be appointed by the Board of Administration from a list of two or more nominees submitted to it by the State Master Councilor. The State Scribe/Treasurer shall be appointed at the Annual Mini-Conclave of this Association, or as provided by Article IV, Section 5(c). He shall not be eligible to run for an elected office for a period of one year after his appointment. All nominees for the office of State Scribe/Treasurer must be a Past Master Councilor, have completed the Leadership Correspondence Course, and be a Representative DeMolay. All Candidates for State Scribe/Treasurer must have a personal savings and/or checking account.
- Section 3(b): The State Scribe/Treasurer shall work with an Advisor who is satisfactory to the Board of Administration. The State Scribe/Treasurer shall obtain three (3) or more bids for the cost of printing the Conclave Proceedings before the registration of said Conclave.
- Section 5(c): A vacancy in an elective State Office may be declared by the State Master Councilor after an evaluation of the State Officer's performance, and with approval of the Executive Officer. A vacancy will also occur in the office of State Scribe upon the recommendation and approval of the State Master Councilor to the Board of Administration.
- Section 5(c): insert "/Treasurer" after "Scribe".
- Section 5(c): A vacancy in an elective State Office may be declared by the State Master Councilor after an evaluation of the State Officer's performance, and with approval of the Executive Officer. A vacancy

- will also occur in the office of State Scribe/Treasurer upon the recommendation and approval of the State Master Councilor to the Board of Administration.
- Section 6(b): In the event of death, resignation, or removal of the State Treasurer, a new State Treasurer shall be appointed by the State Master Councilor, subject to the approval of the Executive Officer.
- Section 6(b): Rename "State Treasurer" to State Parliamentarian.
- Section 6(b): In the event of death, resignation, or removal of the State Parliamentarian, a new State Parliamentarian shall be appointed by the State Master Councilor, subject to the approval of the Executive Officer.
- Section 6(c): In the event of death, resignation, or removal of the State Scribe, a new State Scribe shall be appointed by the State Master Councilor, subject to the approval of the of the Board of Administration, or the Chairman on its behalf.

Although we need to concentrate on membership, we cannot forget these two important aspects of DeMolay.

5) This committee would like to recommend that the S.M.C.R.'s of the state visit other chapters outside their zones. They could learn things to

take back to their zone, and possibly lend suggestions to other zones.

6) Last year's committee recommended that S.M.C.R.'s be included in the state Directory. Due to the failure of the State Staff, this recommendation was not implemented. Therefore, this committee recommends that the names, addresses, and telephone numbers of the S.M.C.R.'s be included in each years proceedings of Conclave.

This committee would like to report on the implementation and effectiveness of the 1986-1987 State Guidance Committee report in this years term:

A) This committee complies with not assigning S.M.C.R.'s to specific chapters, because the S.M.C.R's seem to travel more effectively in the zone.

B) The suggestion to provide S.M.C.R.'s and Appointed State Officers with State Directories has been very helpful in closing the communication gap between the other officers. It should be continued in the future.

c) The suggestion to have the S.M.C.R's arrange activities in their

zone has been very successful where applied.

State Membership Committee

To the Delegates of the 55th Annual Conclave:

We have met and discussed last year's recommendations and how we implemented them.

This committee attempted to comply with the recommendations made by

last year's committee that we meet on a regular basis. We also attempted to mail the progress reports on how each chapter was progressing on its membership quota. The program of the R.D. day, the L.C.C. day, and the traveling orientation Task Force did not meet with success because:

1. Date conflicts between chapters.

2. Not able to get people at the meetings.

3. Each chapter has a different way of handling these three programs This committee, as well as the appointed and elected State Officers, pushed the State Master Councilor's membership plan as suggested by last year's committee. The Big Brother program that was presented last year, was a way to introduce growth ideas to the chapters across the state. We encourage that all chapters start this, or if they have it, continue on. The suggestion that the chapters with less than ten (10) members meet has been changed by I.S.C. to eight (8) members, however, we feel that this is still a valid suggestion. The suggestion made by last year's committee concerning any DeMolay who has not received their R.D. and L.C.C. should obtain them, is a good suggestion and should be continued. We also feel that the Membership Task Force set up by Dad Hunt and several State Officers was a good idea, however some of the goals set up were unrealistic. This is a good program and should be continued.

We, the members of the State Membership Committee, feel that the

following recommendations need to be made:

1. The State Membership Committee Chairman should periodically forward to each chapter a report on the chapter's progress on their membership quota. This information can be obtained from the State Membership Director or the Zone Directors. (Cost for each report \$.25 x # of Chapters = approx. \$15.50)

2. The State Master Councilor should send a letter of congratulations to the chapters that reach 25%, 50%, 75%, and 100% of their membership quota during his term of office and that he should send a letter of congratulations to those individuals who receive their Blue Honor Key during his term.

3. This committee suggest that each Zone Director have quarterly zone meetings. This will improve communications between the chapters in each zone

and this can help in the spreading of membership ideas.

4. This committee suggest that each Chapter submit their ideas and recommendations to the State Membership Committee so that we may be better prepared for Conclave.

5. Considering the amount of time that the State Master Councilor puts into the planning of his membership program, the appointed State Officers should strive to make the program a success in their Zones, and the elected

State Officers should follow it up on a continuing basis.

6. Due to the fact that several chapters within our Jurisdiction do not meet with the minimum membership requirements, eight (8), necessary to formally open, we strongly recommend that all member chapters be encouraged to meet on a regular basis regardless or their size.

7. We strongly recommend that DeMolays who have not received their R.D.'s and L.C.C.'s should enroll in both programs as soon as possible. This will help give us a new source of State Officer candidates.

PROPOSAL DEFEATED 8. We feel that the membership Task Force was a good idea. To help set more realistic goals, we ask that each State Officer in charge of each zone submit a letter, stating the condition of each chapter in that zone, to the State Membership Committee Chairman within sixty (60) days after Conclave. The committee will then meet with the Executive Officer and the State Master Councilor to set up these goals. With more realistic goals this program should

To the Delegates of the Florida State DeMolay Association, as the Order of Knighthood is a working appendant body of the Order of DeMolay, dedicated to extending fellowship and service, we wish to make the following report: Pursuant to the recommendations made at the last FLorida Conclave

the following occurred:

1. The mini-L.T.C. program was removed from the Knighthood program, and turned over to the State Officers for execution by the Executive Officer.

2. The Knighthood Dream Factory fund raising program was combined with the State Master Councilor's Day of Comfort, and placed under the control of the State Master Councilor, in an effort to unify the Dream Factory program within Florida.

3. The Priory of the Month program was suspended due to lack of

interest among the Knights.

4. The Sword and Spurs, the Florida Knighthood Newspaper, was published eight (8) times over the last year, and was distributed to over two

hundred (200) Knights and Priory Advisors at each mailing. nundred (200) anights and Friory Advisors at Each markets of the Sword 5. Due to the continuing popularity and expansion of the of the Sword and Spurs, the position of Editor was added to this committee at the request of the Knighthood Director, and with the approval of the Executive Officer.

6. Over the Course of the last year, four (4) PIKC-MSA's were awarded along with one (1) Green Honor Key. This was unequaled by any other

jurisdiction. 7. A new Knighthood ritual competition was started at Mini-Conclave. The Individual Enighthood Ritual Competition met with such success, that it was expanded to include the Southeastern Regional Knighthood Ritual Competition at the Grand Master's Class.

8. Efforts have been made, with moderate success, to establish Initiatory Degree, DeMolay Degree, and Installing teams within each priory.

9. Florida Knighthood again hosted the Southeastern Regional Grand

Master's Class. This Grand Master's Class was among our most successful. 10. This year, with the approval of the Executive Officer, and the State Master Councilor, the Degree of Triumvirate was instituted within our Jurisdiction. The Degree of Triumvirate is meant to serve as the Chevalier of Knighthood. The Florida Knights who received this degree were; Ed Reed, State Master Councilor, J. Wesley Hyde, State Treasurer, Doug Myers, State Knighthood Prior, Alan Steed, Past Knighthood Committee Chairman, Robert Wallace, Jr., PIKC, and Brett Gordon, PIKC.

11. The Rite of Passage, the majority service for Knighthood, was conferred on numerous occasions throughout the state, and was received well by the Masonic Lodges, the Scottish Rite Consistories, and the York Rite

Bodies.

The following, we would like to submit to the delegates as our

recommendations for the coming year:

First, In an effort to maintain communications between priories, we recommend the continuation of the Sword and Spurs. This being, for the past two (2) years, the Florida Knighthood Newspaper, To ensure that this program is fiscally feasible, we ask that all of the priories, again, contribute the

sum of \$25.00 to defray the cost of publication and mailing.

Second, We feel that it is necessary for each priory to continue to strive to build and maintain an active Initiatory Degree, DeMolay Degree, and Installation team. The Illustrious Knight Commanders would be responsible for organizing these teams, and maintaining them. As each degree part and team is filled, the Registrar is to notify the Knighthood Chairman so that an accurate pool of participants may be maintained.

Third, We recommend that that each Illustrious Knight Commander elect strive for the PIKC-MSA award as one of the methods to keep the Florida

Knighthood program strong.

Fourth, THe Illustrious Knight Commanders should maintain an open line of communication with the Master Councilors, S.M.C.R.'s, and State Officers within his priory area, in order to better coordinate chapter and priory activities.

Fifth, As the Knighthood ritual represents the basis of the Knighthood program, we recommend the continuation of the Individual Knighthood Ritual Competition; which met such success at the last Mini-Conclave and the Grand Master's Class.

Sixth, As all Sir Knights are DeMolays first, we recommend that all Sir Knights make a special effort to take the C.D.J. and H.D.J. courses as prescribed by the Director of Ritual for the Jurisdiction of Florida, in an effort to assist him in judging ritual competition at Conclave. We also

recommend that, at such time as their Zone Director sets up his own zone recommend these Knights offer him any and all assistance he might

seventh, We further recommend that all Sir Knights communicate to their priory areas the dates, times, and places of the C.D.J. and H.D.J. courses, which are currently being planned for this fall.

Executive Committee

To the delegates of the 55th Annual Conclave,

We the members of the 1987-88 Executive Committee would like to make the following recommendations, and report on the action taken on the 1986-87

Precutive committee report.

1) The recommendation, of last year's committee, that the members of each zone meet with the Zone Director at Conclave and Mini-Conclave to plan for the fall and spring area meetings seem to have been ignored or forgotten by the time of Mini-Conclave. The area meetings of 1987 were executed in a well prepared manner, but the spring meetings were a catastrophe and the effects are being felt at this conclave.

These area meetings have many purposes; a) To bring chapters together in brotherhood and make a friend or two, b) To give the members of the chapters a chance to meet the State Officers and vice versa, c) To give the State Officers the time to promote State and International programs such as Conclave, Mini-Conclave, membership, etc. d) To give the Executive Officer the opportunity to meet with the Chapter Advisors and to promote the activities

mentioned above. Therefore, this committee recommends that each zone or combinations of zones hold an area meeting in the fall and spring, to ensure that the DeMolays receive this information. The date for the fall meeting should be set before the last day of Conclave, and the date for the spring area meeting should be set before the last day of Mini-Conclave. This committee, also, recommends that these meetings be held in a location that is conducive to work (i.e. a lodge, or a place where everyone is in a serious frame of mind). It is also a suggestion that another type of fun activity be held during the same weekend, this would attract more participation.

2) The recommendation that was passed by the delegates of the 54th. Conclave concerning the State Committee Chairmen staying in contact with the Zone Directors and the State Staff members who might be able to contribute to his report was not utilized to the extent that it could have been. There are many reasons why, the most obvious ones are:

a) Either there were no staff members assigned to that particular area and/cr

some staff positions changed and no current list was available,
b) A few of the DeMolays who said that they wanted to be the chairman of a
committee at Conclave last year, resigned before their term expired, and a

replacement list was constantly being rewritten.

We the members of the Executive committee have several suggestions on how to improve this situation. To begin with, DeMolays who sign up to be committee chairmen (and any state office for that fact) should take this appointment seriously, and realize that it is not just a "Title", but that there is a lot of work and responsibility attached to the office, and that he is expected to fulfill them all. We also feel an advisor should be assigned to each committee, and when possible, that advisor should be the State Staff member in charge of the same area. When no staff member coincides with a committee, then we ask that a director volunteer for the position of advisor to that committee. The committee chairmen and advisors should be announced at the Installation of Officers on Friday.

3) This committee would like to report on the Grand Master's Class of Region 3, which was held in Ft. Walton Beach on Feb. 26-28,1988. This event was hosted by Florida and we recommend continuing the sponsorship of this Annual Regional Meeting. We encourage all the DeMolays of Florida to attend this event and meet our Brothers from Mississippi, Georgia, Alabama, South

Carolina, North Carolina, and Tennessee.

4) The 1986-87 committee recommended that the International programs be implemented and to distribute this literature in a high priority fashion by the State Officers. The State Officers did this at the fall zone meetings and at the spring area meetings that were held. Many "Prospect Party" or "Texas Plan" packages were handed out and explained, over one hundred of these were handed out at Conclave 1987 and shortly thereafter. Also, the State Membership Incentive programs were handed out and pushed every chance the State Officers had.

5) In an effort to improve communications between the DeMolays of Florida and the State Staff of Florida, we recommend, at the State Staff Conclave Review Session, that a copy of each committee report be distributed

to each member present by the State Master Councilor.

6) The financial report printed in the 54th Annual Conclave proceedings was a move in the right direction for Florida DeMolay, the State Staff members who assisted in the preparation of this report are to be commended. We suggest that an annual report be included in each year's Conclave Proceedings. We also recommend that income as well as expenditures be reported in the future.

This committee would like to thank the Board of Administration for their long hours of work, and dedicated service that each of them provide for the DeMolays of Florida. Pursuant to section 5.01 of the statutes of this Association this committee report is physically and fiscally feasible.

Public Relations and Publications Committee

To the Delegates of the 55th Annual Conclave:

The members of the Public Relations and Publications Committee have met and compiled the following report for your consideration. This committee is filing this report based on two basic opinions. 1) That this committee needs to become more active in this states' problems. 2) That this committee

is basically ineffective in its present state. As a result, we make the is posing recommendations:

This committee may aid this association in its endeavor to become more the known in the areas of each chapter by teaching and promoting better communications among the chapters themselves. It is foolish to assume that committee can rightly show chapters how to stay in touch with their this communities when they cannot stay in touch with their communities when they cannot stay in touch with their own zones and State association. This may be done by the following methods:

A) We suggest that next years Constitutional Revisions Committee change the name of this committee to the State Public Relations and Communications Committee. (Since all publications are communications, the

community purpose of this committee is not threatened)

B) While using the appointed officers of this Association as standing members of this committee may be good in theory, the high rate of turnovers in the appointed line makes this suggestion bad in practice. We suggest that the appulation become the comprised of no fewer than six (6) members and the chairman, taking care to spread the members across the state. This will give the chairsan a steady, stable base with which to work.

c) This chairman should stay in contact with the Zone Directors of this Association and inquire as to the state of communications as well as to the state of inter-chapter activities in each respective zone. With all due respect to the zone directors, this committee feels that we must take the

responsibility for the activities or inactivities of our chapters.

2) In regard to the implementation of last years report, we wish to state that the vast majority of that report was actually observations as to specific events of the state in regards to public relations. Of the true suggestions of the 1986-87 State Public Relations and Publications report:

A) All videos that were in the knowledge of the chairman of this

committee were suggested and recommended as applicable.

B) All chapter newsletters were supported and this committee feels that these newsletters should be encouraged.

c) This committee has worked separately from the State Membership Committee.

3) This committee feels that the state must be more organized in supporting DeMolay week. Planning needs to start at Conclave, continue with the area sestings, and supported by all levels of Chapter, Zone and State Officers. IT IS IMPOSSIBLE FOR THIS COMMITTEE, NO MATTER HOW EFFICIENT, TO BE ABLE TO OMGANIZE SUCH A DETAILED AND VAST EVENT SUCH AS DEMOLAY WEEK WITHOUT GREAT SUPPORT FROM THE STATE.

State Ritual Committee

To the Delegates of the 55th Annual Conclave:

We, the members of the State Ritual Committee, have met and discussed

these recommendations to be brought before you for your approval.

1. In the past, some Conclave and Mini-Conclave sites have not had adequate facilities for ritual competitions. Therefore, it is a suggestion of this committee, that the following appendix be considered in selecting adequate room space for ritual competitions at all future Conclaves and Mini-Conclaves. This would benefit both the ritualists, and the judges, and ensure a better performance in each of them.

2. In accordance with the recommendation accepted by the 54th Annual Conclave delegation, it is again a strong recommendation that each chapter in this Jurisdiction, put at least one advisor and one DeMolay through the Competitive Degree Judges Course. This should help the problem of locating and scheduling qualified judges. If a chapter is knowledgeable of ritual errors, it will create a better ritual program within the chapter, Here are the ways this committee plans to advertise the C.D.J. program to the individual chapters:

A. Through the communication of State Appointed Officers with the chapters, and most especially the State Master Councilor's Representatives.

B. Through the use of the Public Relations and Publications

Committee's monthly report to the individual chapters.

3. It is a strong recommendation as a suggestion to next year's committee, that they further investigate the T.O.C. Ritual Certificate program. It was brought before this committee and we feel it should be further implemented, if feasible, by the next year's committee as a possibility for the Florida State Ritual program. Information in this program can be obtained from the State Ritual Director.

In reporting on last year's committee's performance, here are the recommendations and results of those recommendations over the course of the

- A. The competition for the Recognition Pin Trophy be held at State Conclave and the competition for the Fourth Section be held at Mini-Conclave. This committee feels that this was highly successful in it's purpose of diminishing the load that the Certified Degree Judges must carry at State Conclave.
- B. Each chapter was requested to receive from the State Ritual Director, a new Competitor's Source Handbook which coincides with the XIII edition of the Ritual of Secret Work and the V edition of the Monitor of Ceremonies. This committee feels that this recommendation was not carried out over this past year, and in turn would like to suggest that each chapter obtain a copy of this handbook to further it's ritual program.

C. It is the feeling of this committee that last year's committee recommendations were fair, but some were not implemented to the fullest extent that could have been. This committee urges committees in the future to try their hardest to carry out the recommendations set forth by the previous committee. The future of Florida's Ritual program lies in the hands of this committee, if we can, do our best, then the Florida State Ritual program will

prosper for years to come.

We, the members of the 1987-1988 State Jurisprudence Committee have met several times during this Annual Conclave and would like to submit the following report for your approval:

All committee reports submitted by the chairmen of the various committees have been reviewed and they have satisfied the requirements as described by the Constitution and Statutes of the Florida DeMolay Association.

A. Contrary to recommendations 1 and 3 of last year's report that a strict agenda and proper order of business be executed at the delegate sessions at all future Conclaves, this year's agenda was once again disorganized and haphazard. This committee feels this is a direct result of the committees' lack of preparation prior to, and during Conclave. This committee firmly believes that many of the recommendations that are often approved or suggested are not being implemented at all, or to their fullest extent. Many of those recommendations, if implemented, may be the stepping stones on the road to success for Florida DeMolay in general.

B. In accordance with recommendation 2 of the 1985-1986 Jurisprudence Committee, all committee reports have been approved and signed by the Chairman of the Board of Administration.

It is the observation of this committee that Section 5.17 of the Statutes of this association was not performed. This section is vital in helping the State Master Councilor prepare the agenda of the delegate sessions and could aid in any communication gap the State Master Councilor may foresee with his committee chairmen during the year.

It is also the observation that contrary to Section 5.21, the Committee Chairmen were not fully successful in their attempt to oversee and coordinate the implementation of those recommendations approved by the delegates at the 1986-1987 Annual Conclave.

- We recommend next year's State Parliamentarian/State Jurisprudence Committee Chairman and his advisor develop a detailed outline for preparing a state committee report. This outline should be submitted at Mini-Conclave to the Board of Administration for its final approval and contain the following:
 - A detailed section for reporting on the approved recommendations by a state committee of the most recently concluded Conclave and how or why those recommendations were or were not implemented.
 - b. A section for making any observations the committee feels would be beneficial to the committee chairman and/or members of that committee.
 - c. A section for making any new recommendations that would be beneficial to Florida DeMolay in

We further recommend this outline be distributed to all committee chairmen no later than the closing of Mini-Conclave in 1989 and the closing of all future Annual Conclaves. (For an example of this outline, see attached Appendix A.)

Charter

The several Chapters of the Order of DeMolay in Florida are hereby granted authority to form an organization to be styled "The Florida DeMolay Association". This Association shall exist to further the programs and ideals of the Order of DeMolay, to promote the progress and well-being of the Chapters and their Members, and to provide a medium for education and communication throughout the Order in Florida; provided, that this Association shall have no authority over the particular chapters within this Jurisdiction; provided further, that this Association shall have the authority to exercise jurisdiction over State Master Councilor's Representatives and other such officers as now exist, or may in the future be created, by the Executive Officer.

To accomplish these goals, the Florida DeMolay Association shall be authorized to exact such Constitution, Statutes and resolutions as shall not be in conflict with the policies or orders of the Executive Officer, and shall have been approved in advance by the Board of Administration.

The "Board of Administration" is hereby created to serve the Florida DeMolay Association, its officers and members, in a general advisory capacity. It shall review and approve all legislation to come before the Association, shall have original jurisdiction over any proposition of grievance arising out of the activities of the Florida DeMolay Association, and shall have the authority to construe or dispense with any provision of the Constitution, statutes of rules of competition, when it shall deem such action to be in the other such duties as may be enjoined upon it by the Executive Officer, and shall serve at his Pleasure.

CONSTITUTION OF THE FLORIDA DEMOLAY ASSOCIATION (as revised August 1988)

Article I Name, Purpose, Colors

- section 1: This organization shall be known as the Florida DeMolay Association, Order of DeMolay (hereinafter, Association)
- exclusively educational, religious, and charitable. Not by way of limitation, such purposes shall encompass guidance of DeMolays in their physical, mental, and religious development through specific programs speaking and the arts, all designed to promote a keen sense of the principles of good citizenship, sportsmanship, respect for parents and fellowman, and to establish and instill a philosophy of life that will sustain the members of each Chapter in the future.
- section 3: The Official colors of this Association shall be the royal colors of Purple and Gold.

Article II Allegiance and Authority

- Section 1: The Association, its officers, advisors, and the individuals of member chapters of this Association pledge their allegiance to the International Supreme Council of the Order of DeMolay, its Grand Master, Grand Secretary and the Executive Officer in the State of Florida.
- section 2: This body is constituted with the power and authority to set forth laws and to set forth standards in the inter-chapter relations; and to levy fees and dues, provided that these measures are in harmony with the International Supreme Council of the Order of DeMolay and the Charter under which this Association operates.

Article III Membership and Representation

- Section 1: The members of this Association shall be all the Chartered Chapters, and those holding Letters Temporary of the Order of DeMolay located in the State of Florida
- Section 2: The members of this Association shall meet annually for the purpose of conducting business, electing officers, holding sports and ritual competition and all other activities provided for in the statutes of this Association.
- Section 3: In order for the delegation of a member chapter to attend and register, the said delegation must be accompanied by a Certified Member of the Advisory Council or a Master Mason, approved by the Deputy Zone

Director for each ten (10) DeMolays or fraction thereof in attendance. No Chapter shall be allowed to register its delegation if said Chapter has not paid in full, all assessments due this Association.

Section 4: Each member Chapter Shall be entitled to be represented by three (3) delegates at the Annual Conclave. This Association shall provide by Statute the manner of voting at delegate sessions.

Article IV Officers

- Section 1: The officers of this Association shall consist of the State
 Master Councilor, Deputy State Master Councilor, State Senior Councilor,
 State Junior Councilor, State Parliamentarian State Scribe/Treasurer,
 State Senior Deacon, State Junior Deacon, State Senior Steward, State
 Junior Steward, State Chaplain, State Marshall, State Orator, State
 Standard Bearer, Seven State Preceptors, State Committee Chairman, and all
 others selected by the State Master Councilor and/or Executive Officer of
 the State of Florida.
- Section 2: The State Master Councilor, Deputy State Master Councilor, State Senior Councilor, State Junior Councilor, and State Parliamentarian shall be elected during the general business session of this Association at Conclave assembled each year, and these officers shall serve until their successors are installed.
- Section 3(a): The State Scribe/Treasurer shall be appointed by the Board of Administration from a list of two or more nominees submitted to it by the State Master Councilor. The State Scribe/Treasurer shall be appointed at the Annual Mini-Conclave of this Association, or as provided by Article IV, Section 5(c). He shall not be eligible to run for an elected office for a period of one after his appointment. All nominees for the office of State Scribe/Treasurer must be a Past Master Councilor, have completed the Leadership Correspondence Course, and be a Representative DeMolay. All candidates for the office of State Scribe/Treasurer must have a personal savings and/or checking account.
- Section 3(b): The State Scribe/Treasurer shall work with an Advisor who is satisfactory to the Board of Administration. The State Scribe/Treasurer shall obtain three (3) or more bids for the cost of printing the Conclave Proceedings before the registration of said Conclave.
- Section 4: All other State Officers shall be filled by appointment of the State Master Councilor. These officers shall serve until the close of the following Conclave.
- Section 5(a): No candidate shall be elected to a State Office who would reach the age of 21 years prior to June 1 of the year following his election. No State Officer may attend an out-of-state school or reside outside the State of Florida during his term of office. Any violation of these provisions shall automatically create a vacancy in the office.

- state Master Councilor after an evaluation of the State Officer's performance, and with approval of the Executive Officer. A vacancy will and approval of the State Scribe/Treasurer upon the recommendation and approval of the State Master Councilor to the Board of Administration.
- section 6(a): In the event of death, resignation, or removal of a State councilor, each lower State Councilor shall advance to the next highest councilor, subject to the approval of the Executive Officer.
- paction 6(b): In the event of death, resignation, or removal of the State parliamentarian, a new State Parliamentarian shall be appointed by the state Master Councilor, subject to the approval of the Executive Officer.
- section 6(c): In the event of death, resignation, or removal of the State
 scribe/Treasurer, a new State Scribe/Treasurer shall be appointed by the
 state Master Councilor, subject to the approval of the Board of
 Administration or the Chairman on its behalf.
- section 6(d): Vacancies in all other State Offices shall be filled by Appointment of the State Master Councilor.
- section 7: A Candidates letter of intent to run for elective State Office must include the following statement: "I have read and am familiar with the Charter, Constitution, and Statutes of this association."
- Swction 7(b): All candidates for the office of State Parliamentarian must also include the following statement: "I have read and am familiar with Robert's Rules of Order."

Article V Committees

- Section 1: The following committees shall be considered as standing committees of this Association:
 - 1. Executive
 - 2. Nominations
 - 1. Guidance
 - 4. Credentials
 - 5. Jurisprudence
 - 5. Budget and Finance
- 7. Athletics
- 8. Ritual
- 9. Public Relations and Publications
- 10. Membership
- 11. Knighthood
- 12. Constitutional Revisions

Article VI Amendments

Section 1: The procedure for amending this Constitution is as follows:

- (a): It shall be the responsibility of any Florida DeMolay proposing an amendment to this Constitution to provide for the distribution of said proposal to the Constitutional Revisions Committee, Jurisprudence Committee, Elective State Officers, Executive Officer, Board of Administration, and member Chapters of this Association not less than 60 days prior to the opening session of Conclave.
- (b): The proposed amendment, after the approval of the Jurisprudence Committee and the Board of Administration, shall be presented for consideration on the floor of Conclave. Upon the approval of two-thirds (2/3) of the delegates present and voting, it shall take effect upon the close of the Annual Conclave.

STATUTES

Chapter 1 Revenue

Section 1.01: Each chapter shall pay as dues the sum of fifteen (\$15.00) dollars for each initiate to the Florida State DeMolay Association, Inc. and shall be payable with the form 10 reporting the initiation. In addition, for each member listed on the annual report, the chapter shall pay a per capita tax as follows:

and thereafter this per capita tax will be abolished.

Section 1.015: The revenue derived from the initiation fee in section 1.01 shall be distributed as follows:

33 1/3% General Account

33 1/3% Savings Account

33 1/3% As provided in Chapter 4. Section 4.04

Chapter 2 State Conclave

- Section 2.01: There Shall be ritual competition, athletic competition, State Sweetheart competition, election of State Officers and any other business for the good of the Order or this Association.
- Section 2.02: There shall be ritual competition conducted under the direction of the Executive Officer's Personal Representative for Ritual, assisted by the Chairman of the State Ritual Committee. This competition shall be governed by the rules and regulations of the Original Tournament of Champions.
- Section 2.03: There shall be athletic competition conducted at State Conclave under the direction of the State Director of Athletics assisted

- the State Athletics Committee. The State Director of Athletics, appointed by the Executive Officer, shall appoint for each competition referees for each event who shall use the playing rules established by the Florida State High School Association.
- conclave. There Shall be State Sweetheart competition at State conclave. The rules and regulations as determined by the Executive Officer shall be published in the proceedings of the year's Conclave.
- section 2.05: For the purposes of participation in the activities and/or competitions sanctioned by this Association, any person who has not yet reached the age of 21 years before June 1 of the year of the Conclave Shall be entitled to participate as an active DeMolay, and at any subsequent level of competition; provided that they shall not have been certified as an advisor.
- section 2.06: There shall be a Mini-Conclave, to be held annually in or about the month of January at a specific time and place to be determined by the Executive Officer and State Master Councilor. The Mini-Conclave shall consist of:
 - such meetings of the State Officers as are deemed necessary by the state Master Councilor.
 - b. All State Committees shall be required to meet and report to the state Master Councilor, and
 - c. Any other Ritual and/or Athletic competitions and social activities which are deemed necessary and appropriate.

Chapter 3 Elections

- Section 3.01: Any qualified DeMolay who desires to run for an elective office of this Association shall send a letter of intent to the Executive officer and Chairman of the Nominations Committee, prior to the opening session of Conclave. The letter of intent will be read aloud before the DeMolay delegation by the Nominations Committee Chairman prior to elections.
- Least six months prior to the election and shall be members in good standing of a member Chapter of this Association. All candidates for elective State Office must possess at the time of filing of their letter of intent, proof of being a Representative DeMolay, Past Master Councilor and a graduate of the Leadership Correspondence Course, and copies of such proof shall accompany said letter. Only those brothers who submit a letter of intent for the office of State Parliamentarian shall be eligible to run for said office. All candidates for the office of State Parliamentarian shall have read, and be familiar with, Roberts Rules of Order.
- Section 3.03: All Candidates for the Office of State Master Councilor must be at least 17 years of age and have been a member of this Order for at least two (2) years prior to June 1 of the year of his election.

- Section 3.04: A candidate shall not cause any distribution of materials written or oral pertaining to his candidacy before he has submitted his letter of intention to the proper persons (as stated in Chapter 3, Section 3.01). The date of submission shall be determined by the letter of intent's postmark. He will be authorized to distribute calling cards only this card will be no larger than the standard DeMolay dues card in overall size, and will contain no information other than the name, address, phone number, titles and/or honors and the title of the office being sought by the candidate. This card will be the only authorized material which may be distributed in his behalf at Conclave or at any other time.
- Section 3.05: The election of officers of this Association shall take place at the discretion of the State Master Councilor during a regular business session at each Annual State Conclave.
- Section 3.06: No two (2) elected State Officers shall be from the same member Chapter of this Association.
- Section 3.07: It being the purpose of the Order of DeMolay to develop leadership and a sense of responsibility among individual members of the Order, Elected State Officers or State Scribe/Treasurer of this Association shall not succeed themselves or ever hold a lower ranking office with the exception of a Committee Chairmanship.
- Section 3.08: The election of officers shall be in order of rank, the highest being first, the order as provided by this Constitution, by secret ballot of those entitled to vote, as otherwise provided in the Constitution, at each Annual Conclave of this Association. A majority of the ballots cast shall be necessary for a candidate to be elected.
- Section 3.09: Any qualified candidate who is not elected to the office for which he has submitted a letter of intent may be nominated for a lower office from the floor during elections, subject to the restrictions of Chapter 3, Section 3.02 and Section 3.07.
- Section 3.10: The ballots for the Election of officers shall be prepared by the State Scribe/Treasurer for each Annual Conclave. The ballots shall be distributed to each delegate entitled to vote, prior to the opening of elections, and the ballots shall be cast with the full name of the candidate for the particular office legibly written thereon; ballots shall be folded only once. Blank ballots, illegible ballots and those otherwise abstentions.
- Section 3.11: Each member Chapter shall be entitled to be represented by three (3) delegates at the Annual Conclave. Each delegate shall have one vote in all matters brought on the floor of the Conclave, providing he has Credentials committee prior to the opening session of Conclave. In the event that less than three (3) delegates from a Chapter are in attendance at Conclave, any or all of the absent delegate votes may be given to a Chapter Advisor must submit written authorization to the Credentials Committee before the opening business session of Conclave.

- 3.12: Every Past State Master Councilor who has not reached the age of twenty-one (21) years, and is properly registered, will be entitled to one (1) delegate vote on all matters at the Annual Conclave.
- puring all business sessions, the vote of the delegation shall be ammounted by the chairman of the delegation with the exception of secret ballot for State Officer elections.

Chapter 4 Duties of State Officers

- this Association, and it shall be his duty to perform all duties which naturally pertain to such an office or which may devolve upon him from time to time.
- section 4.02 The State Master Councilor shall preside at the Annual Conclave and work in conjunction with the Board of Administration. He shall also work with the Executive Officer and his Staff in making arrangements of said Conclave.
- chairmen of this Association, and in consultation with each chairman, appoint the committee members.
- Section 4.04: The State Master Councilor shall have an expense account equal to 33 1/3% of the amount collected for each initiate reported to Florida State DeMolay Association, Inc. on a form 10 which shall be used for reasonable expenses incurred in the performance of his and other State Officers duties, with the State Master Councilor's approval.
- Representative, visit each chapter in this state at least once during his term of office so far as is applicable.
- Section 4.06: The State Master Councilor Shall report in writing to the Association at each Annual Conclave, all of his Official Acts, whether performed in person or by Personal Representative.
- State Junior Councilor, State Master Councilor, State Senior Councilor, State Junior Councilor, State Parliamentarian, and State Scribe/Treasurer shall represent The State Master Councilor when so ordered, assist The State Master Councilor in every way possible in the discharge of his duties, and shall report to this Association in writing at each Annual Conclave, all of their official acts.
- Section 4.08: The State Scribe/Treasurer's records shall be subject to an sudit conducted by the Executive officer.
- Annual Conclave of this Association and any official State Meeting. He shall then within sixty (60) days have aforesaid minutes, together with the Constitution and Statutes of their latest revision, published with the

rules and regulations of the Sweepstakes Competition, and distributed as

1. One copy to each member Chapter of this Association; 1. One copy to each member chapter of the Supression to the Executive Officer, one copy to each member of the Supression and advisor appointed to Council residing in the state, and one copy to any advisor appointed by the Executive Officer in a supervisory capacity, including the Board of Administration;

3. One copy to the State Master Councilor, the Deputy State Master Councilor, State Senior Councilor, State Junior Councilor,

and State Parliamentarian;

4. One copy to the International Supreme Council;

5. One copy to each of the State Committee Chairmen; 6. one copy to each jurisdiction in Region 3 of the International Supreme

Council, sent to the Executive Officer.

- Section 4.09(b): The State Scribe/Treasurer, with the approval of the State Scribe/Treasurer Advisor, shall have the authority to correct any grammatical and typographical errors as he deems necessary and appropriate.
- Section 4.10: The State Scribe/Treasurer shall, under the direction of The State Master Councilor, and/or the Association, Conduct all correspondence of this Association.
- The State Scribe/Treasurer shall keep and maintain a true copy Section 4.11: of the Constitution and Statutes of the Florida DeMolay Association. He shall also supply a copy for the Board of Administration, and for the Executive Officer of Florida.
- Section 4.12: The State Scribe/Treasurer shall make disbursement for this Association with the approval of the Executive Officer. The State Scribe/ Treasurer shall make an itemized report of all transactions in connection with his office at the Annual Conclave.
- Section 4.13: The State Parliamentarian shall decide the constitutionality of all motions, resolutions, and proposals presented by the Standing Committees, or from the floor of Conclave, when so requested by the State Master Councilor.

Chapter 5 Committees

- All committees shall be responsible for reporting on the fiscal and physical feasibility of their proposals.
- Section 5.02: The duties of the Jurisprudence Committee will be to determine the Constitutionality of all motions, resolutions, and proposals presented by the Standing Committees or from the floor of Conclave. The State Parliamentarian shall act as Chairman of the Jurisprudence Committee.
- The duties of the Nominations Committee shall be: (a) to receive and review letters of intent filed by person(s) seeking qualification as (a) candidate(s) for elective State Office; upon

completion of the review, the chairman shall notify the prospective candidate of approval, or shall notify him of deficiencies therein; such review and notification shall be completed within twenty (20) days after receipt of the letter by the Chairman; a candidate may submit an amended letter of intent which shall also be reviewed as specified herein above; (b) to, at the time of election, present to the Delegates a list of qualified candidates. No candidates for elective office may serve on this committee.

- section 5.04: The Membership Committee shall study and promote an active program for the acquisition of eligible youth in this Jurisdiction.
- section 5.05: The duty of the Credentials Committee shall be to validate the credentials of all delegates to Conclave in accordance with Chapter 3, Section 3.12 of the Statutes. This committee shall be responsible for arranging the seating of said delegates.
- shall be to promote the image of DeMolay through programs of public interest and to put the name of DeMolay before the general public. It shall also be the duty of this committee to inform and assist member chapters in the Annual DeMolay Week Program. This committee shall oversee any publication of this Association and any related programs.
- the Order of DeMolay throughout this Association, and shall recommend to the Association for approval, procedures for the performance of ritualistic metters not specifically set forth in the Ritual of Secret Work of the Order of DeMolay and methods of receiving introducing, and accommodating those who are entitled to recognition in all Conclaves, meetings, and public ceremonies of the Association. It shall also develop review and revise any State Ceremonies which may be used by this Association.
- Section 5.08 The Athletics Committee shall work with the State Sports
 Director in acquiring qualified, unbiased judging officials for all state
 athletics competitions. they are also to make certain that no advisors
 shall judge their own chapters. they shall also review and submit any
 proposals to the State Master councilor.
- Section 5.09: The duties of the Constitutional Revisions Committee shall be to recommend pertinent and necessary revisions to the Constitution and Statutes.
- Section 5.10: The Knighthood Committee shall maintain communications between Priories in this Jurisdiction and assist the development of Knighthood. The Knighthood Committee shall also coordinate Knighthood programs with current ISC and Jurisdictional programs.
- Section 5.11: The Budget and Finance Committee shall review the financial status of this Association and report the same to the Delegates of the Annual Conclave. Any proposals, including committee recommendations, containing fiscal impact shall be submitted to this committee for its review and recommendation. It shall also be the committee's responsibility

- to put together the Conclave Program and such advertisements necessary its production. This committee shall also present a proposed comprehengly budget for this Association to the delegates and, upon approval present proposed budget to the Executive Officer. The expenditures of this Association shall not exceed its income from Conclave to Conclave.
- Section 5.12: The Guidance Committee shall be the duly appointed State
 Master Councilor's Representatives of the several Zones. This Committee
 will function at the will of the State Master Councilor. It shall act in
 an advisory capacity to relay to the State Master Councilor the suggested
 needs of the individual Zones and the State as a whole. This committee
 shall physically meet at least twice before the opening session of the
 Annual Conclave.
- Section 5.13: The Executive Committee shall be composed of the chairmen of all the committees, the Elected State Officers, State Scribe/Treasurer, and all Past State Master Councilors who have not reached their majority. It shall be chaired by the State Master Councilor, and shall meet at his discretion.
- Section 5.14: The State Master Councilor shall announce the names of the appointed Committee Chairmen, appointed State Officers, and State Master Councilor's Representatives at the last business session of the State Conclave. The names of the Chairmen shall be published, with the exception of the State Credentials Committee Chairman in the current proceedings of this Association.
- Section 5.15: The State Master Councilor shall have the authority to appoint one Advisor to each committee with the consultation of the committee chairman and the director, if one has been appointed.
- Section 5.16: It shall be the duty of each committee to submit to the State Master Councilor a report upon request. It shall also be the duty of each State Committee Chairman to gather suggestions and recommendations from the member Chapters and combine them with his own ideas and submit them to the State Master Councilor as a tentative agenda thirty (30) days prior to Conclave.
- Section 5.17 The final committee reports shall be typewritten and submitted to the State Scribe/Treasurer no later than the beginning of the last business session at each Conclave.
- Section 5.18: A final report from each State Committee must be read and passed by a simple majority vote of the delegates prior to the close of Conclave.
- Section 5.19: The State Master Councilor Shall have the power to establish and abolish additional committees (with the exception of Standing Committees) as he deems necessary.
- Section 5.20: Each individual State Committee shall be responsible for implementing the recommendations made by that committee and approved by the delegates at the most recently concluded Conclave. The Executive Committee shall oversee and coordinate this implementation.

Chapter 6 State Master Councilor's Representatives

- fection 6.01: It will be the duty of each State Master Councilor's gepresentative to promote Florida DeMolay and its Communications to the members of this Association.
- mertion 6.02: It will be the duty of each State Master Councilor's Representative to provide monthly reports to the State Master Councilor, Guidance Committee Chairman, and State Officer in charge of his Zone, concerning the progress, activities, and needs of his Chapter and Zone.
- to attend all meetings of the Guidance Committee of this Association.
- personal Representatives of the State Master Councilor's Representatives shall act as personal Representatives of the State Master Councilor to serve on his behalf when no other ranking State Officer is present.
- Saction 6.05: Each Zone will have one (1) State Master Councilor's Representative for every three chapters or fraction thereof. The State Master Councilor's Representatives shall be appointed by the State Master Councilor to serve at his will.
- Section 6.06: State Master Councilor's Representatives shall be obligated to attend both Mini-Conclave and Conclave.
- mection 6.07: All State Master Councilor's Representatives shall be required to begin working on their L.C.C. and R.D within 30 days after their appointment, if they have not previously completed them. Proof of which, must be furnished by his Chapter Advisor.

Chapter 7 State Appointed Line Officers

- Section 7.01: State Appointed Officers of this Association shall include: the State Senior Deacon, State Junior Deacon, State Senior Steward, State Junior Steward, State Orator, State Sentinel, State Chaplain, State Marshall, State Standard Bearer, State Almoner, and the Seven State Preceptors.
- Promote the Florida DeMolay Association and its communications to the Members of this association.
- Tection 7.03: It shall be said Officers duty to provide monthly reports to the State Master Councilor concerning the progress, activities and needs of his Chapter and Zone.

- section 7.04: Said Officers will be required to attend all meetings of $t_{\rm he}$ Public Relations and Publications committee.
- Section 7.05: Said Officers shall act as Personal Representatives of the State Master Councilor when no other ranking officer is present.
- Section 7.06: Said Officers will be required to memorize their portions of the Ritual Ceremonies.
- Section 7.07: Said Officers shall be required to begin working on their L.C.e. and R.D. within thirty days after their appointment if they have not previously completed them.
- Section 7.08: Said Officers shall be obligated to attend both Conclave and Mini-Conclave, unless circumstances deem otherwise.

Chapter 8 Amendments

- Section 8.01: These Statutes Can be amended by a simple majority vote of the delegation, and such amendments may be submitted any time prior to the first business session of Conclave, and need only be submitted to the delegates of the Chapters in Attendance at the Conclave.
- Section 8.02: These amendments shall, upon the approval of the Board of Administration and the delegation, take effect upon the close of the Annual Conclave.

State Sweetheart Rules for Sweethearts, Female Guest, and Chaperones

General Rules

There must be an adult female chaperon (for every three (3) female to attend any Conclave function. Chaperones must be at least 25 years ald. NO EXCEPTIONS! Chaperones must room with the female guests during Conclave. chaperones should conform to all rules and regulations, including the dress code.

All female guests and their chaperones must be officially registered through an active DeMolay Chapter with the approval of the Advisory Council.

- In the case of problems or questions, contact the State Sweetheart Chairman or Committee ONLY! DO NOT contact the Hotel Staff.
- All Sweethearts must be sponsored by and Active DeMolay Chapter. They must be a Current Chapter Sweetheart. One entry per Chapter will be accepted.
 - Sweetheart Contestants must be between the ages of 15-20 as of July 1 of the year they compete and attending a Florida School or be a High School graduate. They must wear mane tags at all times and are required to attend the first briefing session.
 - All Sweethearts should exemplify the highest DeMolay ideal of womanhood and conduct themselves in a ladylike manner.
 - Sweetheart Contestants can not be engaged to be married, annulled or divorced.
- Sweetheart Contestants must have their parents' (or guardians) approval in writing and submitted to the State Sweetheart Chairman before the beginning of Conclave.
- Each Sweetheart Contestant and her chaperon must be registered and 7. staying at Conclave (in the same room) the entire Session. The chaperon must know where her Sweetheart is at all times. A Sweetheart chaperon may not chaperon anyone else. We must adhere to a one-on-one basis.
 - Sweetheart Contestants will be permitted to run no more than twice for State Sweetheart. Any girl who has been State Sweetheart is ineligible to run again.
- A suitable 5x7 photo, preferably in color, must be submitted to the State Sweetheart Chairman the first day of Conclave. No other size photo will be accepted, and the photo will not be returned. (photo with crown and sash will be permitted.)

pictures, cards, brochures, or any other campaign materials WILL More be distributed by a Sweetheart or for her by others. Sweethearts or female guests will not campaign in any way for candidates running for DeMolay State Office

- Any infraction of these rules by anyone may cause a Sweetheart Contestant to be disqualified from competition.
- 12. Sweetheart Contestants may not leave the hotel premises without a chaperon and permission slip form a member of the State Sweetheart Committee.
- 13. No DeMolay will be permitted to enter a Sweetheart's room without having a Sweetheart Committee member present.
- 14. Sweetheart Contestants are not permitted in the vicinity of the ballot box while DeMolays are voting for State Sweetheart.
- 15. Each DeMolay will vote for three (3) girls for State Sweetheart, indicating their first, second, and third choice. Each first place vote will receive three (3) points; second place will receive two (2) points; third place will receive one (1) point. The girl receiving the highest number of points will be the State Sweetheart. There must be three different, eligible Sweetheart manes on each ballot.
- 16. A member of the B.O.A. shall be present at the counting of the votes to assist the Sweetheart Committee.
- 17. The State Sweetheart can not serve concurrently as a Chapter Sweetheart. She must resign from her Chapter Sweetheart position upon elections as State Sweetheart.
- The State Sweetheart must notify the State Sweetheart Chairman within 15 days of her election who her official Chaperon will be; the Chaperon must meet with the Chairman's approval. The State Sweetheart must be chaperoned at all times!
- 19. It is the duty of the State Sweetheart to keep the State Sweetheart Chairman informed, at all times, of her activities.
- 20. Any engraving done on the State Sweetheart trophy and crown box will be paid for immediately by the State Mother's club on presentation of a Bill the the State Scribe/Treasurer.
- 21. The State Sweetheart is responsible for the crown, sash, cape, trophy, and trophy box which will be returned to the State Sweetheart Chairman, in the same condition they were received in, at the beginning of Conclave or upon request.
- 22. State Conclave registration for the outgoing State Sweetheart will be paid by the Florida DeMolay Association. (contact State Sweetheart Chairman.)

- If the State Sweetheart marries, becomes engaged to be married, moves out of Florida, or leaves for 30 days, she must resign and return all 33. state paraphernalia. The 1st runner-up will replace her.
- The State Sweetheart should be willing and able to travel to various parts of Florida to DeMolay activities, and also, to State DeMolay 74. functions where invited!

Dress Code

- Dresses are recommended for most functions. It is understood that at 2. all times bras, panties, slips and nylons will be worn with all dresses.
